**CORRECTION/APPROVAL OF MINUTES**: The minutes of the December 2023 Faculty Organization meeting were approved.

### **REPORTS OF OFFICERS:**

**Dean of the Campus** – C. Catledge, report submitted (Appendix 1).

Page 1: Enrollment is up to over 2000 students (up 17.75% from last spring). We have two faculty searches in progress. The baseball season is starting this weekend; please try to support our athletics. We have 2 new employees: Breana Jones and Kasie Faulkenberry, full-time recruiters.

Page 2: 2<sup>nd</sup> 8 weeks Sun City course is coming up on Archaeology in the Olde English District taught by Chris Judge. There is a link to Ed2go continuing education in the report. Carolina Day is 2/13 with 16 people going including 12 students. Horizon education grant applications are coming up. The Lunch and Learn with First Lady Aggelopoulou-Amiridis is 1/26. This is SC legislative budget season so we made our presentation to the SC House Ways and Means Committee. The Senate presentation will be in next 2 weeks. Save the date for Gift for Garnet. Our commencement is

Saturday, April 27 at 11am, outdoors. Our commencement speaker is Dr Walt Collins. Dr. Collins was recently recognized at the Lancaster County Chamber of Commerce as Volunteer of the Year.

C. Bundrick: is there any news about the new dean search process?

C. Catledge: no update

S. Alhaddad: is there an update on the bookstore transition?

C. Catledge: no update. Middle of semester it is transferring to new ownership.

S. Criswell: what happens with electronic books when we transition, specifically with getting Spring 2 books to students?

C. Catledge: no clear answer, but they are working on Spring 2 having materials available for students

Associate Dean for Academic and Student Affairs –T. Lekan, report submitted (Appendix 2).

Page 1: Welcome to Courtney Catledge in her new role as interim dean. 2024-25 review schedule email is coming around March 1 if eligible for promotion, 3<sup>rd</sup> year review, or if retiring. These Review Intent forms are due by March 15. Please fill out the survey on Service and Scholarship, which will go to the Chancellor; it is important to show the work we do. REDcap is a survey tool that may be useful for those who do surveys as course components.

Post tenure review successes: Criswell, Kinkade, Berry, Freeman. See email about Blackboard Ultra training through CTE, 2/16 11am; Excel grants call is out with a 3/1 deadline; USCL Career Fair is 3/19 on campus, details to come; possibly another at the Indian Land location in April which will be open to public.

- S. Criswell: BB Ultra training is great (Gloria Washington in particular) and you can make appointment for individual tutorials.
- D. Lawrence: links to training calendar are available. If you are going up for tenure or promotion, look for an email from Fernanda about the campus description that will go out to external reviewers.

Academic Success Center – P. Lawrence, report submitted (Appendix 3).

ASC is open until 5 on Thursdays (an extension) and also there is availability virtually for those later appointments. Caysen Horton is the new nursing tutor.

Support: if you want automatic reports of your students' visits to the ASC, send P. Lawrence an email. Celebrity Tutors are when we bring in faculty. If you want to do this, please reach out. If you want a workshop or study session before a big exam, we can do that. And it brings students into the ASC, which helps students overcome obstacles that keep them from using the ASC in the future. Dual enrollments students can use the ASC and we track that data.

**Director of Student Success and Retention** – A. Schryer, report submitted (Appendix 4).

The new Student Athlete Success Coordinator Natalie Calhoun is working part time and mostly remote, but she can come to campus as needed. The goal for this position is to streamline and facilitate communication with coaches, trainers, faculty, staff, and students. She will be communicating practice and game schedules. She will prompt students to tell their faculty, but also arm faculty with information we need so it matches what the athletes tell us. Two weeks before a game, she will reach out to faculty.

Athletes also need to communicate practice/game schedules with academic advisors, ensuring that missing things won't interfere with degree progressions. Natalie will be point person for any student-athlete issues.

Long term she will be working on orientation for all student athletes to facilitate onboarding and communicate a common message of expectations with full support of the athletic director. There is a push for trying to help international student athletes and even out-of-state student athletes acclimate to our campus.

- B. Obi Johnson: athletics advisory committee will be meeting with Natalie to discuss everything, including mid-semester checks.
- F. Marques Burke: Bettie and I are working with Asheley to create the 2<sup>nd</sup> year of the Summer Science Scholars program (see webpage). This is for incoming first year

students interested in majoring in science. It allows them to come on campus early and take Chem 101 and one math course, depending on their placement, for free. Beyond the classroom experiences, seminars and field trips are planned. The program is currently accepting applications.

### **REPORTS OF COMMITTEES:**

### **USC SYSTEM COMMITTEES:**

### Provost's Advisory Committee -- S. Criswell, A. Yingst

Items discussed at the meeting: as we are teaching campuses, T&P expectations should be weighted differently. There has been difficulty finding outside reviewers who are tenured from 2-year campuses. The response was possibly putting out a list of peer schools. The issue of having faculty names on the main USC website should be discussed with Walt Collins.

USC Columbia English dept decided to have all ENGL 101 and 102s in Blackboard Ultra this spring, rather than FA24 with the rest of the USC system. That decision and others in the past (Math, Language) have been made without informing PC campuses. Is it possible to have one PC faculty member at one USC department meeting per year? Also be aware that this coming academic year Thanksgiving will have a full week off, which only gives new hires 2 days before they begin teaching to on-board into Blackboard and other systems. That isn't enough time.

We want to clarify in our T&P files on what our loads are and how that affects tenure expectations. The provost wants us to tie back to our guidelines at our 2-year campuses. She did confirm that pedagogy is appropriate scholarship.

### LOCAL COMMITTEES:

### **Evaluation Committee** – K. Holland

Changes under new business are designed to add some loose guidelines to lower the anxiety for those going up for post tenure review.

### Executive Committee - D. Lawrence, F. Burke

- D. Lawrence: Upon consultations, the social gathering will be better attended if it is directly after an event people are already there for, so for the 4/5 FO meeting D. Lawrence proposed that we meet in person and have a catered event after that meeting. Poll given and majority voted for 4/5 being an in-person meeting this year.
- F. Marques Burke: With respect to upcoming elections, see email soon with ballot showing slots that need filling. Please reach out to Fernanda if you are interested. Hope to finalize ballot in March to vote in April.

### RPS Grant Committee - S. Sellhorst

Will be opening up a mini grant CFP because we had approximately \$7k left from the December granting process. The criteria and format are the same; the only change is that we will remove the requirement that you couldn't have received a grant during the previous year, which opens the application to everyone. Date will be sometime in March and we will get that information to you. There is no limit on the project and it is based on merit. Will have date by next faculty meeting.

### Tenure & Promotions Committee – D. Lawrence, R. Freeman

At 1/31 meeting we discussed first year review and post tenure review files. At the end of Feb meeting we will begin discussing the FIFS.

### **NEW BUSINESS:**

Motion to revise FIF Document and Annual Peer Review Description—USCL Evaluation Committee, K. Holland. (Appendix 5,6)

FIF Document: If you are going through post tenure review you still have to turn in a FIF, since post-tenure review is state-mandated. So, the motion is to delete the third box as non-substantive.

Annual Faculty Peer Review Description: under "Exemptions from Annual Faculty Peer Review" the motion is to delete "or post tenure review" so that it now reads "Faculty members preparing files for first or third-year review or the tenure and promotion process may be exempted from the annual faculty peer review process."

Last page there is an addition of a section "Guidelines for Post-Tenure Review."

Purpose is for clarity and consistency.

### Discussion:

C. Bundrick: I would encourage us not to vote today and give people time to read and think through it. Due date does need clarification, whether it fits in November with 3<sup>rd</sup> year review and tenure filings or in January with FIFs. When exactly would 6 years fall?

Motion to postpone voting until the next meeting. Voice vote passed.

- S. Penuel Second to last line could be misunderstood as what would be required (versus sufficient). Summary of previous 6 years' FIFs should be just one way this is accomplished.
- S. Criswell keep the word "sufficient." Need discussion about the purpose of these (other than being mandated by the state). How else might it be useful? This would be good for the evaluation committee to discuss.
- C. Bundrick Should anything having to do with Post-Tenure Review even be in the Annual Faculty Peer Review document? Should it be its own separate document?

- B. Obi-Johnson Is the PC Faculty Senate working on this problem as well? Is there someone in that group that can discuss how this might affect what we are doing on local level?
- R. Freeman yes, the PC Faculty Senate has been clarifying the language, but not specifying for the individual campuses what is required. They are clarifying in the manual that it is up to the campuses themselves what their T&P looks like. Also USC Sumter updated theirs and she can share that with the committee.
- D. Lawrence a document dedicated to Post Tenure review would be helpful.
- T. Lekan "sufficient" does not mean "necessary" so that's a good point. Need to understand the nuance.

The Chancellor reports on the grand totals for all 5 PC campuses, and so the reported numbers don't identify any individual's work or even the work of an individual campus. The Chancellor would like to make year-to-year comparisons, and so it's very important that we have 100% participation. We are exploring the possibility of offering study-skills workshops this spring or a study-skills studio service on a recurring basis. We would love to hear your thoughts on how best to support student study strategies, organization, note-taking, and other habits in this format.

We are looking forward to a busy semester helping students with their academic challenges. However, the first month of the year has felt slow following the very heavy traffic of the fall. Illness and scheduling difficulties have also made things a bit unpredictable over the last month, but we are looking ahead to February optimistically.

### **Summary of Tutoring Data**

**Year-to-year trends:** With 33 appointments, January was not as busy as the previous year but was busier than 2021. This indicates we face some challenges maintaining the strong momentum of the fall, but we aren't seeing an unprecedented or alarming drop in service. We are working on new promotion and outreach efforts, and we expect traffic to naturally pick up as we near exam time.

Session distribution trends: Session distribution data for the month shows our typical ratio among STEM, BBCE, and Humanities courses. STEM comprises a little over half of all appointments and a significant share of that represents our support of students in MATH 111i. We are seeing very low demand for virtual sessions at this time, which bears watching. The total number of sessions for the month is too low to draw definitive conclusions about this, however.





### **CALL FOR EARLY ALERTS**

We know the importance of connecting with students early and often (occurring within the first six weeks) are ideal. We are requesting that faculty submit early alert forms for any student that is not attending class, missing assignments, or who would benefit from a contact by a student success staff person. This form will remain active throughout the semester.

### Early Alert - My USC Lancaster | University of South Carolina

When outreach is sent to early alert students, they receive information about the Academic Success Center and important deadlines for dropping/withdrawing from classes. Students are also always encouraged to contact their professor about the issue and any questions they have. Depending on the situation, students may also be sent information about other resources on campus: IT help, counseling services, Financial Aid, the Food Pantry, etc.

### **Update:**

As of 1/26/24, 42 alerts have been submitted for Spring 2024. Last year at the same time, 30 alerts had been submitted for Spring 2023. Although alerts have increased, more faculty are participating in this process and identifying students that need extra support. 15 faculty members have participated in early alert this semester as compared to 12 faculty members at this time last spring semester. Consistent with last spring semester, spring 2024 early alerts have been submitted for students not attending class (including online classes) or for students not submitting coursework.

Out of the 42 alerts submitted, 20 alerts (47%) have been closed. 12 alerts were closed because the students dropped the class or was dropped for nonpayment. The other 18 alerts were closed because the issue was resolved or the student started communicating with the faculty member about the issue. Students have responded to communication sent at a rate of 60%. Student responses included not realizing the class started, having issues accessing their school email and Blackboard, and not fully understanding assignment requirements.

### **NEW STUDENT-ATHLETE SUCCESS COORDINATOR**

Natalie Calhoun joined USCL in January as the new Student-Athlete Success Coordinator. This part-time position will assist with athletics retention and success through communication with coaches, student-athletes, the athletic trainer, faculty, and staff.

#### Duties include:

- Communicating practice and game schedules with students and faculty.
  - o Guiding students through the process of communicating their game schedules and potential absences with faculty early on in the semester.
- Reviewing student-athlete schedules for potential conflicts. Working with the student-athlete and advisor should any issues arise.
- Raising awareness about athletic events on the campus.
- Serving as a point person for student-athlete issues.
  - o Directing student-athletes to necessary resources and alerting appropriate staff as needed.

Natalie will also be working with Athletics and Student Success to create an Orientation for all student-athletes. This would include programming aimed at providing support for international and out-of-state student-athletes.

Natalie comes to us with experience in the field of athletics administration and communications. She spent three and a half years at Winthrop University as the Assistant to the Athletic Director. Her duties included coordinating meetings and managing the schedule for the Vice President for Intercollegiate Athletics. She also worked with men's and women's basketball programs regarding recruiting travel, team travel, and purchases and coordinated the annual Athletics Hall of Fame. In addition to her daily responsibilities, she also worked closely with the Senior Associate Athletic Director on the athletic budget, onboarding/hiring process, and reconciliations. Prior to Winthrop, Calhoun spent three years at Duquesne University in Pittsburgh, PA as the Assistant Director of Athletic Administration. She also served as the Sport Administration Championships Assistant at the Eastern College Athletic Conference (ECAC). Additionally, Calhoun has served as the coordinator of championship events at the 2012 Mid-American Conference Basketball Championship and interned with the Boston Red Sox in their video scouting department.

Calhoun was a 4 year all-conference starter for the Saint Vincent College women's volleyball team in Latrobe, PA and graduated in 2011. She resides in Lancaster, SC, and is mom to twin boys Parker and Weston (3) (and dog Sidney).





# ANNUAL FACULTY PEER REVIEW UNIVERSITY OF SOUTH CAROLINA LANCASTER

### PURPOSE

As stated in the *Palmetto College Campuses Faculty Manual*, the University of South Carolina is committed to annual review of all faculty. On the University of South Carolina Lancaster campus, each faculty member must undergo an annual peer review. The peer review process is designed to provide an opportunity to document the professional development of the faculty member, and to provide regular and constructive evaluations of the performance of the faculty member. Annual Peer Review also provides an opportunity to assess the contributions of the faculty member to the mission of USC Lancaster.

### EXEMPTIONS FROM ANNUAL FACULTY PEER REVIEW

Each faculty member is required to undergo annual faculty peer review. Faculty members preparing files for first or third-year review, or the tenure and promotion process, or post tenure review may be exempted from the annual faculty peer review process. Those faculty members should refer to the *Manual* and to USC Lancaster's policies for the specific requirements of these reviews. Administrators subject to administrative review by faculty may elect not to undergo annual faculty peer review in addition to administrative review.

### PREPARATION OF THE ANNUAL FACULTY PEER REVIEW FILE

Annually each faculty member shall complete a Faculty Information Form (FIF) detailing the faculty member's professional activities conducted during the previous calendar year. The FIF is arranged according to the criteria for tenure and promotion found in the *Palmetto College Campuses Faculty Manual*, and the faculty member is encouraged to consult the *Manual* closely in the preparation of the FIF. The criteria stated in the *Manual* recognize three broad areas: Effectiveness as a Teacher and/or Librarian, Scholarship, Service. In documenting effectiveness for these criteria, the faculty member should focus specifically on their contributions to the mission of USC Lancaster in the performance of each of these areas.

### **FACULTY EVALUATION**

The Local Tenure and Promotion Committee evaluating the annual peer review files of tenured and tenure-track faculty will evaluate faculty on three categories, assigning a rating of Effective or Not Effective in each category, as well as an overall rating of Effective or Not Effective.

The Instructor Peer Review Committee will use the same method to evaluate full-time instructors, but because those instructors do not have a scholarship component to their job responsibilities, their evaluation will be based on Effectiveness as a Teacher and/or Librarian, omitting the Scholarship ranking. Full-time instructors who have scholarship accomplishments to report have the option of choosing to be evaluated by the Local Tenure and Promotion Committee with the scholarship category included. A faculty member wishing to be evaluated in this way should indicate that preference by checking the appropriate box on the FIF.

For a description of the current criteria for each of these areas, please refer to the most recent edition of the *Palmetto College Campuses Faculty Manual*. It is important that the faculty member include activities in each relevant section of the FIF, and the faculty member is encouraged to present limited narrative providing context and explaining the importance of the most significant activities included in the file. Faculty members should note that within the category of service, USC Lancaster sets a high priority on service to the community.

### PROCEDURES AND DEADLINES

Annual peer review shall be conducted according to the following schedule:

- January 31 The faculty member shall have submitted a completed FIF to the office of the Associate Dean for Academic Affairs.
- The office of the Associate Dean for Academic Affairs shall have provided the appropriate review committees (hereafter referred to as "the committees") access to the FIF for each faculty member undergoing annual faculty peer review.
- April 30 By this date, each member of the faculty will have received from the committees a written evaluation on the Peer Review Form (PRF). Each faculty member must sign his or her PRF acknowledging that the evaluation has been completed. This signature does not necessarily constitute agreement with the evaluation, and every faculty member has the right to respond to the annual peer evaluation in writing. The original of the signed PRF shall be given to the faculty member, and a copy shall be given to the Associate Dean for Academic Affairs, who will maintain the copy as a part of the faculty member's personnel file.
- May 31 By this date, any faculty member who wishes to respond to the annual peer evaluation in writing must have submitted his or her response to the Associate Dean for Academic Affairs. Any written response from a faculty member to his or her PRF must be attached to the copy maintained in the office of the Associate Dean for Academic Affairs.

### COMMITTEE PROCEDURES

Annual Faculty Peer Review will be conducted each year by the Tenure and Promotion Committee and the Instructor Peer Review Committee as detailed above. Evaluation of the faculty member will be based on the FIF submitted by that faculty member, and the evaluation will proceed in the following manner.

- 1. After review of the FIF, each member of the committees will evaluate the performance of each faculty member, producing brief comments for each of the areas of the criteria.
- 2. The appropriate review committee will meet and discuss each of the areas, determining an overall ranking for each candidate in each area as Effective or Not Effective, as well as an overall ranking for each candidate. If the committee cannot determine a ranking by

consensus, the committee will conduct a vote with a tie resulting in a ranking of Effective. The committee should also at this time discuss and justify individual narrative comments and edit those comments for clarity as the committee deems necessary. It is desirable that the committee reach consensus in the preparation of the narrative comments, but when necessary, dissenting comments shall be included.

- 3. The Chair of each committee will collate the comments for each faculty member being evaluated and include these comments in the narrative section of the PRF.
- 4. Each member of the appropriate review committee must sign the PRF. These signatures do not necessarily indicate that all members of the committee agree with all comments on the form or the overall ratings, but rather indicate that the committee members have reviewed the PRF and that their comments and ratings have been included in the process.
- 5. Members of the committees may not participate in their own peer evaluations, and as such, members of the committees will not sign their own PRF's, except to acknowledge their receipt of the finished form at the completion of peer review.

### GUIDELINES FOR POST-TENURE REVIEW

As outlined in the faculty manual, every tenured faculty member shall undergo Post-Tenure review once every six years after receiving tenure. (Submitting an application for Full Professor satisfies this requirement.) For post-tenure review, a summary of FIFs for the previous six years (including the year of post-tenure review) is sufficient. ### 1) W-2s for Tax Year 2023

If you elected to receive your W-2 electronically please take the following steps to review, print, or save your 2023 W-2.

- 1) Log into the HR/Payroll System hcm.ps.sc.edu
- 2) On the Employee Self Service screen choose the Payroll tile
- 3) Select the W-2/W-2c Forms Tile
- 4) Ensure that the Tax Year is 2023
- 5) Select View Form
- 6) If you need instructions on filing your W-2 select the square under the heading filing instructions.

Those who did not choose to receive the 2023 W-2 electronically will receive their copy via mail. It will be mailed to the home address that is stored in the HR/Payroll system.

When communicating with the USC Payroll Department share your legal name and USC ID so that the representative may easily identify you and help efficiently.

### 2) Timesheets

Supervisors of student assistants and temporary employees please ensure that you are approving timesheets on a weekly basis.

"All weekly timesheets are due to be submitted and approved by 5:00pm on Monday for the prior week unless otherwise requested."

If an employee does not submit a timesheet, reach out to remind them or submit and approve the timesheet on their behalf.

When timesheets are not approved weekly it affects the employee's paycheck and typically results in them having to wait until the next pay period to receive compensation.

### 3) Personnel Request Forms

Personnel Request Forms for both new and rehired student assistants and temporary employees should be approved at least two weeks prior to the employee's anticipated start date. All Personnel Request Forms must be approved by the Supervisor or Department Head, Associate Dean, Business Manager, and the Dean prior to initiation of the hire or rehire process.

This is to ensure that the hire/re-hire process is complete, which allows the employee to have a smooth onboarding experience and be productive on their first day of employment.

Rehires typically lose access to their university email account and other systems at the end of each appointment. They will not be able to regain access until the HR/Payroll system recognizes them as an active employee.

### 4) 2024 State ORP Open Enrollment

Current participants of the State Optional Retirement Program (State ORP), administered by the SC Public Employee Benefit Authority (PEBA), may participate in the upcoming open enrollment period from January 1 to March 1, 2024.

During the annual open enrollment, State ORP participants may either choose to change their State ORP service provider by logging in with their <u>Member Access</u> account or change to the South Carolina Retirement System (SCRS) by contacting their campus Benefits Office to request SCRS enrollment if it has been at least one year, but not more than five years since initially enrolling in State ORP. If State ORP participants change to SCRS, this decision is permanent and cannot be reversed.

Current State ORP participants need to determine how their contributions are to be invested and to designate a beneficiary for their State ORP account balance. Changes made during the open enrollment period become effective April 1, 2024.

Changes to the participants' status in the <a href="Member Access">Member Access</a> account will not be shown until PEBA processes the State ORP to SCRS open enrollment transactions in March. After March, the individual's State ORP account will continue to reflect an active status, but an SCRS account will appear with an inactive status. After the second enrollment job runs in May, the individual's SCRS account will change to active, and the State ORP account will change to inactive. ### **OPPORTUNITY SCHOLARS PROGRAM**

### **Enrollment Update**

- Our OSP project is in year four of a five-year grant cycle which will conclude on August 31, 2025. We are currently serving 133 freshmen and sophomores from first-generation, low-income, or disabled backgrounds. Recruitment initiatives are in place, and as a result, we are in a good position to more than meet our enrollment requirement of 165 qualifying students prior to the end of the current reporting period on August 31, 2024.
- The Department of Education (ED) requires that 2/3 of our official enrollment must consist of students who are double qualifiers, i.e., students who are either low-income/first-generation or low-income/disabled. 
### **USCL Cares Angel Tree Campaign**

### **LEGISLATIVE UPDATES**

### **Congressional Appropriations**

- Congress recently passed its third Continuing Resolution (CR) just one day before a partial government shutdown would have been triggered. The new CR has extended government funding into March, once again staggering the funding deadlines to two different dates: March 1 and March 8. This third short-term CR is necessary to give the appropriators time to develop funding bills at the new FY24 spending level agreed upon between the House and Senate. Appropriators believe they will wrap up FY24 by the start of next month to allow them to get started on FY25 this spring.
- According to COE, failure to pass appropriations bills by April 30 will trigger automatic sequestration, resulting in a 10% cut to non-defense discretionary programs, including Federal TRiO Programs.

### **Negotiated Rulemaking for Higher Education 2023-24**

- On November 29, ED announced its intention to establish a rulemaking committee to prepare proposed regulations for federal programs authorized under Title IV of the Higher Education Act of 1965, as amended (HEA).
- In December, ED chose four individuals from each sector (current or former participants in a federal TRiO grant project, HEIs, public or private agencies or organizations, including

community-based organizations with experience in serving disadvantaged youth, secondary schools, including local educational agencies with secondary schools) to represent the TRiO community on the rulemaking TRiO subcommittee and one TRiO individual as an alternate for the larger rulemaking committee which will review proposed regulations for many different HEI topics.

This subcommittee first met on January 12 and will meet again on Friday, February 9. More details may be found at the link listed below:
