August 26, 2025

The AAGDC Meeting was held on Tuesday, August 26, 2025 at 2:00 p.m. at the Darla Moore School of Business.

Opening Remarks, Welcome, and Agenda Review - Dean Ann Vail

Dean Vail welcomed the group and asked if there were any additional items for the agenda. A discussion about the Doctoral Advisory Committee was added. She also introduced Harlan Smith.

International Student Arrival and Enrollment - Harlan Smith

- Harlan Smith reports to Sam Todd, Vice Provost and Associate Vice President for Global Affairs, and collaborates with the Dean of The Graduate School on shared challenges.
- New Student Information and Data System: This system will bridge the gap between ISSS (International Student and Scholar Services) and academic units, addressing legal compliance and international student academic progression.
- There will be an advisor of record assigned to each college or school, with possibly two for larger ones.
- International Student Enrollment Update:
 - o 440 new international students enrolled at all levels.
 - An additional 80 students are expected in January due to delayed visa approvals.
 - Students must now prove they are solely coming to the U.S. for academic purposes.

- All F1 and J1 visa holders must have a visa interview and social media will be vetted per new government requirements.
- Graduate assistants may not work from abroad; their location will be coded in the system.

- Heidi Conte New Assistant Dean for Enrollment Technology.
- Barbara Foster New Chief of Staff for The Graduate School.
- Lucy Yu New Associate Dean for Academic Affairs and Student Engagement.
- Bill Hauk New Chair of Graduate Council, Associate Professor of Economics, and Director of the 1-year MBA program.

Graduate Expo - Dean Vail

- Date: September 5th, from 9:00 a.m. to 12:00 p.m. at Russell House.
- New feature: Workshops based on student requests from last year.
- An "Ask the Graduate School" booth will be available.

Grad Launch - Dean Vail

- Pilot Testing: A Graduate Student Orientation/Onboarding course is being tested with two sections this fall. Both sections have reached capacity, and there is a waiting list.
- The course aims to provide additional onboarding support and foster a sense of belonging. Peer institutions have found it effective.
- Some institutions offer it as mandatory, while others make it optional.

Federal Mandate Related to Digital Accessibility - Dr. Lucy Yu

- Implementation Timeline: USC aims to fully comply with federal digital accessibility requirements by April 2026.
- Focus on electronic dissertations and theses.
- A formatting guide and template will be provided to students to ensure compliance.
- Workshops (both online and in-person) will be held to assist students with compliance.

Program of Study Automation - Dr. Angelina Sylvain

- The University is automating Graduate School forms using Dynamic Forms. The Program of Study (POS) form will go live on September 2nd.
- Paper Forms: Paper forms will be accepted until January 2, 2026. After this date, only electronic forms will be accepted.
- Dean Vail noted the need to improve POS completion, as many students arrive at graduation clearance without a completed POS.
- The new automated system aims to address compliance issues and improve program productivity.

CHE and "Stop-Out" Master's Program - Dr. Angelina Sylvain

- The Stop-Out Master's Program is a degree PhD students can receive on their way to completing their PhD.
- Moving forward, PhD students must be enrolled in the master's program at the point of enrollment to ensure program productivity and avoid issues with the Council of Higher Education (CHE).
- Program coordinators are encouraged to monitor their programs and flag any that need attention.

Student Services Staffing - Satish Jayachandran

- The Moore School is seeking an optimal advisor-to-student ratio. Historically, it was 1:175, but the digital shift may require adjustments.
- Undergraduates follow a more routine checkup model, while graduate students may have more complex needs.
- Different advising strategies for professional part-time and full-time students.
- It was suggested that we consider hiring advisors who could work weekends.

Enrollment Management System: Element 1801 - Dr. Angelina Sylvain

- Element451 has been selected as the new enrollment management system, to be known as Element1801 at USC.
- It will replace CollegeNet and will support the entire student lifecycle, from prospecting to graduation.
- Launch Timeline:
 - o Kickoff: September 9, 2025.
 - Discovery Phase: September October 2025.
 - o Initial access: February 2026.
 - Full system launch: March 2026.
 - o In-person training sessions: February March 2026.
 - Recurring training sessions: April 2026.
- The importance of collaboration in the transition, including feedback and messaging support from Graduate Directors and faculty was emphasized.

Doctoral Advisory Committee - Danny Jenkins

- Concerns were raised about implementing the Doctoral Advisory Committee (DAC). This third committee would be separate from the comprehensive exam committee.
- Some institutions use DACs for orienting students and introducing them to the program.
- It was clarified that the DAC could overlap with the dissertation committee.
- The group discussed the need for policy adjustments to clarify language and streamline the process.
