Research Infrastructure/Administration (Bonilha):

Research Funding Updates

General update:

- Total Awards Across All Sources increased substantially, rising from \$30.32 million to \$44.37 million, which represents a 46.4% increase. This represents growth in funding from non-federal sources (e.g., state, foundation, industry).
- **Proposals Submitted** rose from **239** to **256**, indicating about a **7% increase** in research proposal activity.

Higher Education Research and Development (HERD) update:

The HERD research funding data from 2022 to 2025 shows both fluctuations and notable growth in specific research categories:

Applied Research more than doubled over the period, rising from \$1.82 million in 2022 to \$3.45 million in 2025, indicating a strong upward trend in funding for practical, application-oriented projects.

- Basic Research grew steadily from \$19.38 million in 2022 to a peak of \$22.12 million in 2024, but then declined to \$19.04 million in 2025, showing a recent contraction of approximately 14% from its peak.
- Research Training experienced consistent growth, nearly tripling from \$35,089 in
 2022 to \$102,953 in 2025, reflecting increased investment in training initiatives.
- Research Development saw the largest relative growth, expanding from just \$4,210 in
 2022 to \$418,863 in 2025— more than a 100-fold increase, suggesting a growing emphasis on developing new research capabilities.
- Total HERD Funding increased from \$21.24 million in 2022 to \$24.95 million in 2024, but then fell slightly to \$23.02 million in 2025, reflecting the drop in basic research funding.

Summary Insight:

While total HERD funding dipped slightly in FY 2025 compared to FY 2024, the trend over four years shows **expanding support for applied research, research development, and training**, suggesting a diversification of research priorities beyond basic science.
